1. WHAT IS THE CURRENT PURPOSE OF THE PROPOSED GIFT REQUEST?

To help complete the creation of the <u>JA Living History Archival Initiative</u> which includes (1) creation of the Junior Achievement Pioneers' Museum of Junior Achievement History, located at JA Worldwide Headquarters, Colorado Springs, Colorado; (2) ongoing development of the JA Archives which are housed in the Ruth Lilly Library at Indiana University/Purdue University Indianapolis; and (3) to continually update the written history of Junior Achievement.

2. WHO WILL BENEFIT AND HOW MANY PEOPLE WILL BE SERVED?

JA currently impacts 6.5 million students **annually** and has served 51 million students since 1919, who are now our alumni. JA employs approximately 2,000 staff members and enjoys the ongoing involvement of over 1,500 retired employees, who comprise the Junior Achievement Pioneers. The Museum will be visited by worldwide staff who come for training and education updates, as well as visitors from around the world, while the web-published history and permanent archives are available to all who seek information, past and present, about JA.

3. WHY IS YOUR ORGANIZATION AN APPROPRIATE GROUP TO MEET SUCH NEEDS?

Junior Achievement's mission is to provide all students with the tools and inspiration to make their future the best that they can be. We work with children from 5-18 years of age, helping them set goals as they strive to learn-by-doing and appreciate the Free Enterprise System. Showcasing the history of JA allows today's students to learn from and about the hard work and entrepreneurial spirit of our world's great business leaders and emulate them in the future.

# 4. HOW WILL THIS PROJECT BE SUSTAINED (OR MAINTAINED) WHEN THIS REQUESTED FUNDING CEASES?

The overall budget will allow the completion of all three phases of the project, as well as ongoing maintenance, periodic updates to the displays and annual updates of the written history. The museum displays will be fully rotated every six months to showcase the amazing quantity of materials already archived, as well as additional items being secured and catalogued daily. Once we have achieved the campaign's goal, initial funding needs will be satisfied.

5. WHAT OTHER FUNDERS ARE INVOLVED IN SUPPORT OF THIS EFFORT?

The most amazing aspect of this project is that the majority of funding secured has been provided by the current and retired employees of Junior Achievement. Through an effort called "The Heritage Campaign", to-date more than 300 employee gifts have already been made that total \$203,000. Additional investments have been received from Lilly Endowment Inc., El Pomar Foundation, The Colorado Visitors and Convention Bureau and several others. The final phases of the campaign will focus on JA Worldwide board members and additional corporations and foundations.

6. WHAT PERCENT OF THE PROJECT BUDGET IS THIS REQUEST?

Working with architects, interior designers, contractors specializing in commercial construction, electrical specialists and others, we created a detailed plan to convert this beautiful space, with huge windowed walls overlooking the Cheyenne Mountains and Pikes' Peak, into an exciting place for our associates and guests from around the globe to spend many hours learning and reflecting on the result and impact of our Free Enterprise System.

The JA Living History Archival Initiative Committee is now ready to enter the second and final phase of its project to identify, securely store and display the many items that will keep the organization's history alive and available to all.

A total budget of \$750,000 has been developed to cover the expenses of completing this project. Included in this budget are:

Continued identification of archival materials from JA operations world-wide, with regular submissions to the Junior Achievement Archives at the Ruth Lilly Library in Indianapolis

Completion of the Living History interviews that will then allow the creations of the book detailing the organization's progress over the past 85 years. Annual updates will also need to be funded in order to insure that the history book will never become out-dated

Construction of the Archives Museum at the Junior Achievement Worldwide Headquarters in Colorado Springs, Colorado

In order to achieve this funding goal, several actions have already been taken:

A campaign has been initiated that will allow current and retired Junior Achievement professional staff members to provide financial support for the overall archives project.



Letters of request have been sent to the nearly 2,000 people who have given a substantial portion of their working life to the Junior Achievement family. Through this campaign, we hope to raise \$225,000 toward the overall archives project. We are pleased to announce that we have already secured over \$203,000 from this effort!

## A campaign for "gift-in-kind" donations has been initiated.

Requests are being submitted to firms who produce and distribute items required in the construction of the Museum for donation of the needed items as tax deductible "gifts in kind". For instance, we are currently working with a firm for the donation of a series of flagpoles that will allow us to have an ever-changing display of flags of our 98 member nations.

Extensive research is being completed to identify high-potential donors. A significant gift for the Museum portion of the project has been secured.

We are identifying foundations, corporations and individuals who understand and appreciate the need to create and maintain Living Archives for organization's whose reach has enhanced the lives of young people around the globe. Proposals will be written and submitted for gifts ranging from \$10,000 to \$50,000.

Mr. Jim Hemak, a past employee of Junior Achievement and now a prominent business owner, has already committed \$100,000 towards the creation of the physical museum.
